For **FUNBIO**, the security and protection of the personal information of all those visiting our website or engaged in our activities is very important.

We are publishing this Privacy Notice to inform users of the following terms:

**FUNBIO** is a registered non-profit organization and has a responsibility to safeguard and secure all personal information it collects for the purposes outlined in this Privacy Notice.

By visiting any website, portal or system belonging to **FUNBIO** or its partners, or by providing personal information for the purposes listed herein, you are agreeing to the practices described in this Privacy Notice and authorizing the use of the data supplied to the site, or collected whilst visiting the site, its subdomains or applications. Rest assured that your personal data will be managed with the utmost care and responsibility, in accordance with the highest data-protection and privacy standards.

**FUNBIO** collects your personal information for the purposes mentioned in this Privacy Notice. All data will be managed and stored lawfully and in good faith, within the bounds of the organization's remit, respecting the legal principles of suitability, appropriateness and proportionality; the inviolability of the user's honor, privacy and personal image; informational consent and self-determination; responsibility and security.

The information collected by or supplied to **FUNBIO** will be managed in the strictest confidence, unless otherwise determined in the organization's [Privacy Policy](#). All data will be safeguarded appropriately and only used toward the following ends:

### Primary Ends:

- To identify the user as a partner, supplier, investor, donor, person or company under contract, beneficiary; recipient of assets, transportation costs, services and resources; employee, grant holder, etc.
- To obtain contact information for the delivery of contracts and goods; receipt of resources and/or services, and to send information relevant to **FUNBIO**'s activities and dealings with the user;
- For use by systems engaged in activities relating to the user's relationship with **FUNBIO**;
- To facilitate integration between systems engaged in activities relating to the user's relationship with **FUNBIO**;
- To answer queries, provide assistance and carry out activities relating to the user's relationship with **FUNBIO**.

### Secondary Ends:

- To identify visitors entering information or content onto the site;
- To obtain contact information so **FUNBIO** can send newsletters and inform the user of events organized by **FUNBIO** or its partners;
- To send notifications about our projects;
- To send notifications about any alterations to this Privacy Notice;
- To run analytics that do not identify the user personally;
- To build a profile of visitors to **FUNBIO**'s website and social media. **FUNBIO** uses cookies and browser session data so that it can develop a profile of the public visiting its site. This is done so that we can improve our content. User information is managed securely throughout this process. Bear in mind that the processing of user data is completely automatized, with no

human handling involved.

As the owner of the information discussed in this Privacy Notice, you have the right to know which data will be stored, to what ends it is used, and under what conditions. As such, you are entitled to exercise your rights of Access, Rectification, Cancellation and Opposition. Furthermore, provided you have no current contractual obligation to **FUNBIO**, you may, at any time, deauthorize us to store and use your personal information.

So that we can safeguard and secure your personal information in the most adequate way possible, **FUNBIO** has adopted the [European Union's General Data Protection Regulation](#) (GDPR) 2016/17, issued by the European Parliament.

As such, we draw the user's attention to the following rights concerning how their personal information is processed:

- **The Right to be Informed:** In the event of security breaches, leaks or other exposure, **FUNBIO** will inform the user as to the vulnerability and its nature within the period of ten (10) days after the event first comes to light.
- **Right to Suppression:** The user can request that personal data be suppressed when no longer necessary to the ends for which it was collected, among other reasons.
